# Our Core

Hydro Tasmania is Australia's largest producer of renewable energy, with a diverse portfolio that includes hydro, wind, solar and gas-fired electricity generation, energy retailing, and specialist consulting services. At the core of our operations is the management of critical water resources and infrastructure, which underpins both our energy production and our long-term sustainability. We manage an extensive network of dams, hydropower stations, and water systems to meet the state's energy needs and seek to *accelerate the renewable energy transition*.

## Our Core Materialities:



### Water Management

Water is at the heart of what we do. As Australia's largest water manager, we are entrusted with the stewardship of vast and precious water resources, balancing the needs of energy generation, environmental sustainability, community, and economic use. Our approach to water management meets today's needs and safeguards this critical resource for the future.



### Energy Generation

Hydro Tasmania produces about 9,000 gigawatt hours (GWh) annually of clean renewable electricity from hydropower in an average inflow year. That's enough to power about 900,000 Australian homes and small businesses. We also own the gas-fired Tamar Valley Power Station in northern Tasmania and part-own two Tasmanian wind farms, with a combined annual output of around 1,000 GWh. Hydro Tasmania's strategy for the future is rooted in growing and adapting Tasmania's energy generation capacity to meet future Tasmanian market needs. We are supporting new on-island VRE developments, advancing major infrastructure projects and accelerating investment in our existing hydropower assets.



### Customers

We aim to make informed decisions that reflect our customers' evolving needs. We take time to listen, learn and adapt so we can deliver affordable, innovative products and impactful solutions, striving to build a brighter future for the people we serve.



### Infrastructure

Infrastructure underpins our ability to deliver reliable, efficient, and sustainable energy to Tasmania. The strength and resilience of our extensive network of dams, hydropower stations, and supporting assets are critical to our ongoing operations. Maintaining this infrastructure is essential for meeting Tasmania's electricity needs and supporting the renewable energy transition.



# Environment

As champions of renewable energy, we seek a clean, healthy and sustainable future for all. Our water licence gives us stewardship of six Tasmanian water catchments, making us the largest freshwater manager in Australia. Environmental management is an integral part of our business.

Our environmental management is underpinned by a certified ISO 14001 Environmental Management System (EMS).

### Health, Safety & Wellbeing

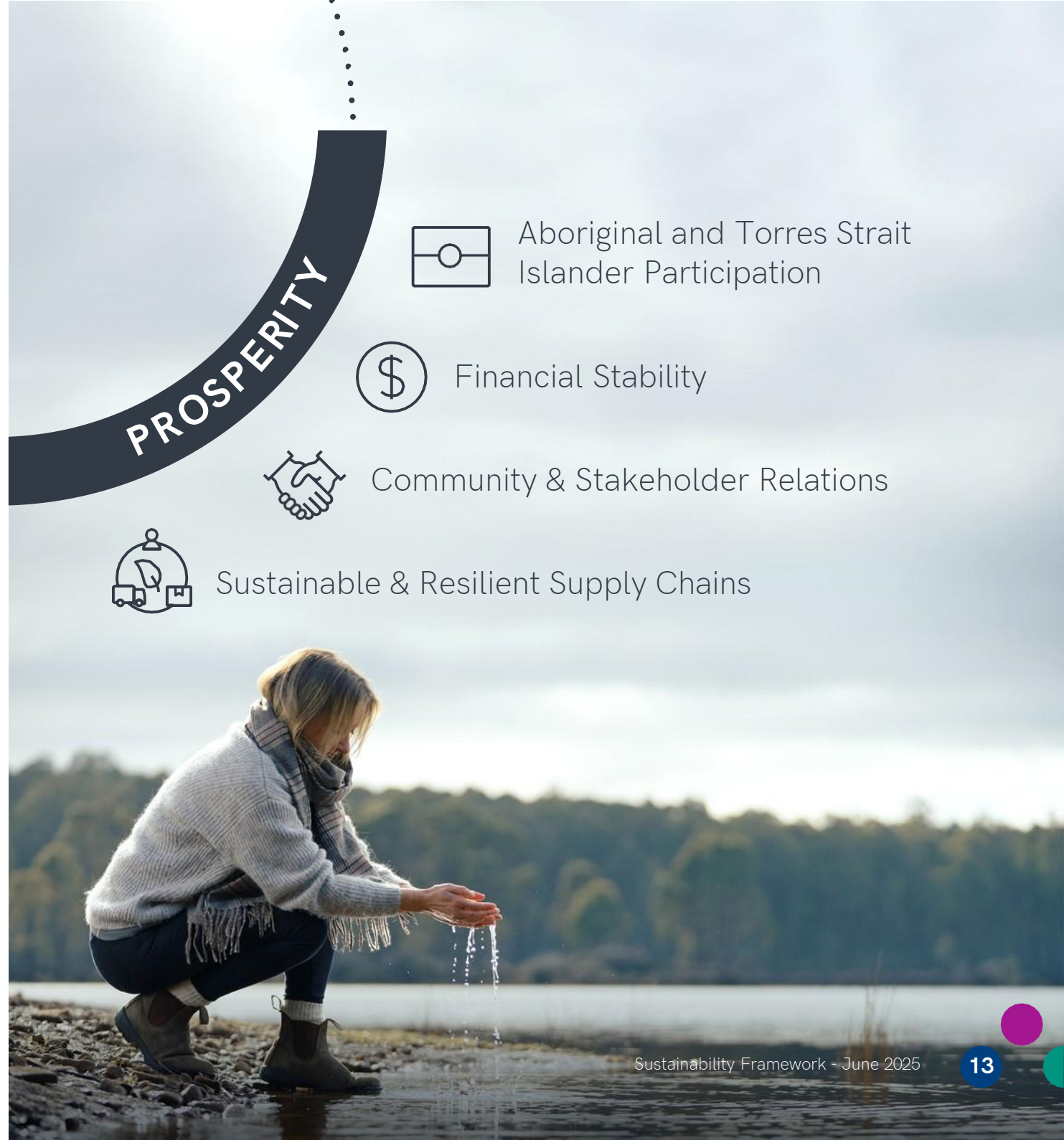

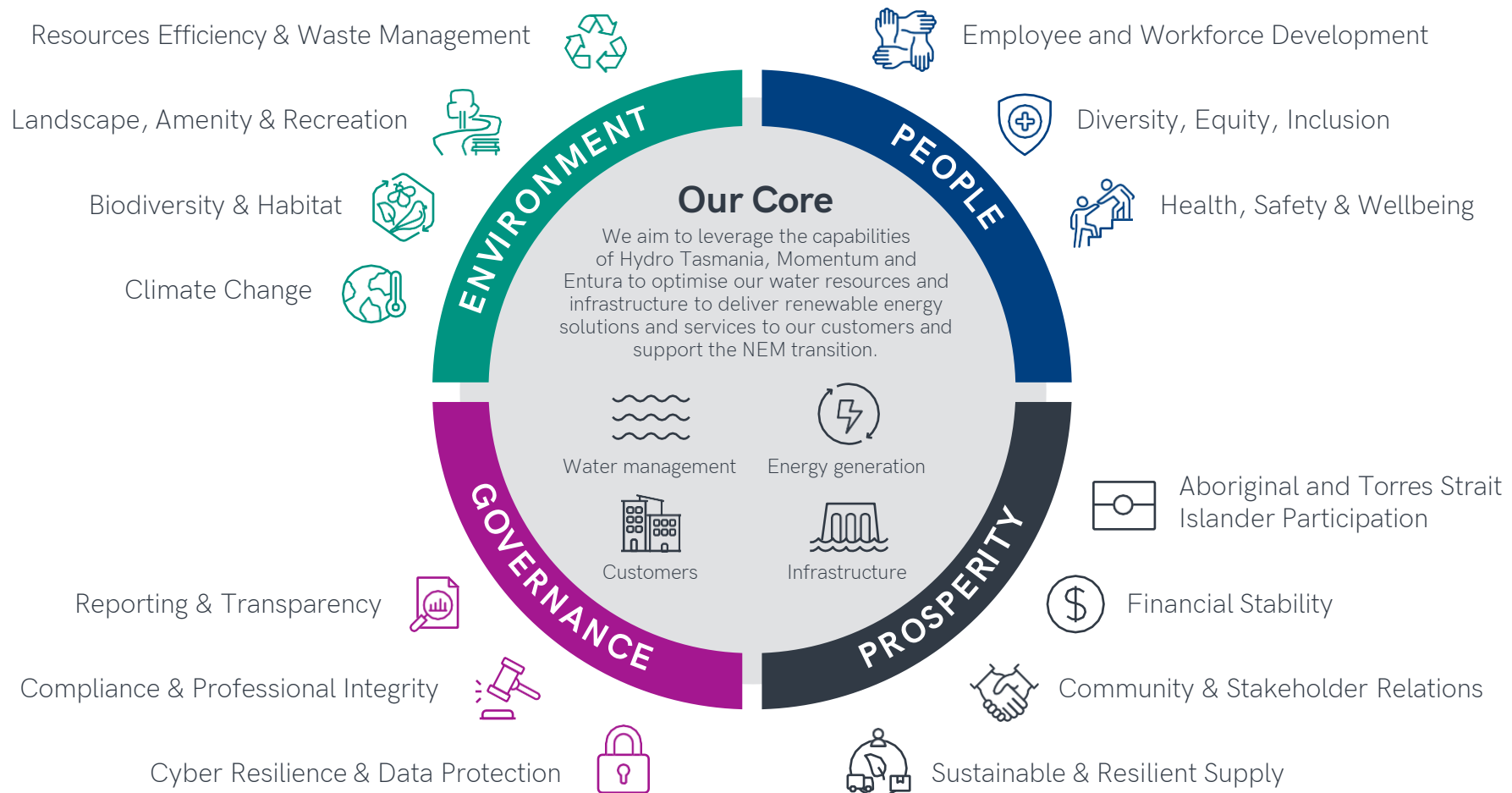
